

WHO MAY APPLY TO THIS ANNOUNCEMENT:

 Career or career conditional employees, Veteran's Canteen Service and permanent Title 38 employees of the Portland VA Medical Center eligible under the interchange Agreement.

MAJOR DUTIES:

The Nurse Educator (EDSIMLAB) position includes oversight of the simulation lab and supporting the educational needs of all medical-surgical staff. Fifty percent of the job responsibilities are devoted to oversight of the simulation lab, including chairing the Simulation Workgroup, implementing project goals, coordinating daily operations of the simulation lab, such as scheduling, ordering and stocking supplies, and equipment maintenance. The incumbent will collaborate with health care professionals to develop scenario-based practice concepts. The Nurse Educator will provide administrative, clinical and technological support to staff during scenarios. The incumbent will provide technical support for simulation for the entire Medical Center; develop and maintain an archive of learning materials, and participate in grant-writing and research. The other fifty percent of the job duties will include supporting the educational needs of all medical-surgical staff to include the following: development and oversight of a competency program, collaboration with Clinical Managers to ensure completion of core competencies and unit-specific competencies, perform needs assessment to determine learning gaps, implement project goals, and collaborate with advanced practice nurses to develop and provide educational inservices. Assignment may require evening and night work. Advanced computer skills to include both hardware and software knowledge. CPRS knowledge preferred. Organizational skills. Self-motivated.

THIS POSITION IS IN THE BARGAINING UNIT

QUALIFICATION REQUIREMENTS:

Experience: Minimum 2 years RN experience. Advanced computer skills required. Experience in Staff Education and/or Health Sciences preferred.

<u>Eligibility</u>: Department of Veterans Affairs Qualifications Standards (VA Handbook 5005, Part II, Appendix G6) for AD/VN-610 series applies and may be reviewed in the Human Resources Management Service Office.

- Graduate of a school of professional nursing approved by the appropriate State agency and accredited by one of the
 following accrediting bodies at the time the program was completed by the applicant: The National League for
 Nursing Accrediting Commission (NLNAC) or The Commission on Collegiate Nursing Education (CCNE).
- In cases of graduates of foreign schools of professional nursing, possession of current, full, active, and unrestricted
 registration and the possession of a Certificate from the Commission on Graduates of Foreign Nursing Schools
 (CGFNS) will meet the requirement of graduation from an approved school of professional nursing.
- Current, full, active and unrestricted registration as a graduate professional nurse in a State, Territory, or Commonwealth (i.e., Puerto Rico) of the U.S. or in the District of Columbia. The RN must maintain a current, full active and unrestricted registration to continue employment with the VA.
- For Nurse II, the applicant will have a BSN with 2-3 years of nursing experience **OR** an Associate degree or diploma in nursing and a bachelors degree in a related field and 2-3 years nursing experience **OR** a Master's degree in nursing or a related field with a BSN with 1-2 years of experience.
- For Nurse III, the applicant will have a Master's degree in nursing or related field with a BSN and 2-3 years of nursing experience OR a Doctoral degree in nursing or related field and 2-3 years of nursing experience.
- For Nurse IV, the applicant will have a Master's degree in nursing or related field with a BSN and 4-5 years of nursing experience **OR** a Doctoral degree in nursing or related field and 3-4 years of nursing experience.

CONDITIONS OF EMPLOYMENT:

Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future

Under Executive Order 11935, only United States citizens and nationals (residents of American Samoa and Swains Island) may compete for civil service jobs. Agencies are permitted to hire noncitizens only in very limited circumstances where there are no qualified citizens available for the position.

All information submitted to this VA Medical Center is subject to verification by VetPro.

If you are a male born after December 31, 1959, and are at least 18 years of age, civil service employment law (5 U.S.C. 3328) requires that you must register with the Selective Service System, unless you meet certain exemptions.

A security clearance and a favorable suitability determination are required. Misconduct in prior employment, criminal, dishonest or disgraceful conduct, habitual use of intoxicating beverages, abuse of narcotics, drugs or other controlled substances, or reasonable doubt of loyalty to the United States are examples of reasons an offer of employment may be denied.

Public transit subsidy benefits are available. Carpooling assistance is provided. However, single occupancy parking is limited on main Portland campus.

Eligible employees may be non-competitively reassigned to fill this position as an exception to merit promotion.

Applicants selected for this position may be appointed to a temporary appointment, NTE 13 months, pending completion of boarding process.

A drug test may be required for an applicant who is tentatively selected.

A pre-employment physical examination will be required for an applicant who is tentatively selected.

Applicants appointed to direct patient care positions must be proficient in spoken and written English as required by 38 USC 7402(d) and 7407(d).

APPLICANT'S PLEASE NOTE:
