

NOTICE OF VACANCY

### WHO MAY APPLY TO THIS ANNOUNCEMENT:

- Career or career conditional employees and permanent Title 38 employees and permanent Title 38 Hybrid employees of the Portland VA Medical Center eligible under the interchange Agreement. Included are permanent employees of the Willamette National Cemetery, Regional Office, Veterans Outreach Center and Veteran's
- Career or career conditional employees and permanent Title 38 employees of other VA facilities.
- Applicants with competitive status outside the VA i.e., those with transfer or reinstatement eligibility.
- VEOA (Veterans Employment Opportunities Act) Veterans who are preference eligibles or who have been separated from the armed forces under honorable conditions after 3 or more years of continuous active service.
- **Noncompetitive Appointment of Certain Military Spouses** 
  - o Spouses of armed forces members who are involved in a Permanent Change of Station (PCS): You must include a copy of the service member's PCS Orders authorizing the spouse to accompany the service member and proof of marriage to the service member.
  - o Spouses of armed forces members who retired or were released from active duty with a 100% disability: You must include proof that service member was released or discharged from active duty due to a serviceconnected disability, documentation of 100% disability, and proof of marriage to the service member.
  - o Un-remarried widows or widowers of armed forces members killed while on active duty. You must include proof of service member's death while on active duty and proof of marriage to the service member.

Employees covered under the provision of the inter-agency Career Transition Plan (ICTAP) and Career Transition Assistance Plan (CTAP) (displaced VA Employees) eligibles will be given priority consideration for vacancies within the local commuting area for which they are well qualified. Applicants requesting this consideration must attach appropriate proof of the ITCAP eligibility with their application. Well qualified is defined as an applicant, without any further training, can perform the major duties of the position which include expediting administrative procedures to allow efficient patient care throughout the continuum; responding to questions from patients concerning services; providing advisory and technical assistant to patients, administrative staff and professional staff regarding medical care; and providing administrative functions for the facility.

## **MAJOR DUTIES:**

Develops the need for and maintains an awareness of available resources, and makes recommendations to Medical Center management regarding needs, distribution or redistribution of these resources. Responsible for full authority for a large number of fund control points which are budgeted for a total of several million dollars. Provides for the budgeting and financial management for the division. This includes budget formulation, justification, and execution; financial management; and financial reporting. Provides advice to management and program personnel on budgetary and finance issues. Performs as an expert in budgeting and financial management on a large departmental level.

Reviews budget estimates submitted, analyzes program plans and information, and identifies need for changes. Responsible for preparation of justification. Prepares presentation materials for budget

submission to the medical center budget committee and participates in budget presentation. Maintains a continuing review of operating and financial programs. Determines the need for budget reprogramming and initiates the necessary action. Makes analyses of program reports, financial statements and other accounting data, correlating and verifying information. Ensures funds are properly allocated and spent in a timely manner.

### **QUALIFICATION REQUIREMENTS:**

Specialized Experience: Experience that equipped the applicant with the particular knowledge, skills, and abilities to perform successfully the duties of the position, and that is typically in or related to the work of the position to be filled. To be creditable, specialized experience must have been equivalent to at least the next lower grade level in the normal line of progression for the occupation in the organization. Specialized experience includes, but is not limited to, the ability to develop rapport with all echelons of an organization, use of qualitative and quantitative analysis methods for assessment and improvement of programs, developing, implementing and monitoring a volunteer service or similar program, establishing short-term and long-term goals, and communicating with internal and external customers to promote medical center services, programs and opportunities.

## BASIS OF RATING: (Knowledge, Skills, Abilities (KSAs)

On a separate sheet of paper, provide a written, detailed response to each of the KSAs. Failure to respond to the rating factors may result in your application receiving a less than desirable rating.

- 1. Ability to meet and deal with others and to communicate in writing in performing administrative analysis work.
- 2. Knowledge of VHA and PVAMC goals and objectives and relationships of the assigned program with other key functions within the agency.
- 3. Knowledge of health care delivery program concepts, practices and procedures.
- 4. Knowledge of the federal budget process and financial management practices and procedures.
- 5. Ability to analyze organizational and operational problems and develop solutions.
- 6. Ability to manage human resources and organization resources.

#### **CONDITIONS OF EMPLOYMENT:**

- Although the duty station is shown in this announcement, it may be necessary to utilize the selected person's services at a different location within the Portland VA Medical Center commuting area if conditions require it in the future
- Applicants without prior federal service will be appointed at step one of the grade
- Eligible employees may be non-competitively reassigned to fill this position as an exception to merit promotion.
- Under Executive Order 11935, only United States citizens and nationals (residents of American Samoa and Swains Island) may compete for civil service jobs. Agencies are permitted to hire noncitizens only in very limited circumstances where there are no qualified citizens available for the position.
- If you are a male born after December 31, 1959, and are at least 18 years of age, civil service employment law
  - (5 U.S.C. 3328) requires that you must register with the Selective Service System, unless you meet certain exemptions.
- A security clearance and a favorable suitability determination are required. Misconduct in prior employment, criminal, dishonest or disgraceful conduct, habitual use of intoxicating beverages, abuse of narcotics, drugs or other controlled substances, or reasonable doubt of loyalty to the United States are examples of reasons an offer of employment may be denied.
- Public transit subsidy benefits are available. Carpooling assistance is provided. However, single occupancy parking is limited on main Portland campus.

Failure to submit your narrative response to all of the KSAs will result in the applicant not being referred for the position.

- 7. ITCAP Applicants: Submit proof by including a copy of the agency notice, most recent Performance Rating and most recent SF-50 indicating current position, grade, level, and duty station.

#### **APPLICANT'S PLEASE NOTE:**
